VIII. DEPARTMENT REPORTS

HR Update

Jennifer Letourneau reviewed the current open positions within the department including Grounds & Facilities Maintenance Assistants, Grounds & Facilities Maintenance Technicians, and part-time seasonal positions.

Jennifer Letourneau informed the committee that two of the locations for the Summer Youth Program due to a lack of staffing. Councilperson Shakeenab asked how that decision was made. Jennifer Letourneau responded that the two locations that were chosen did not qualify for the summer lunch program.

Councilperson Streetman inquired when the Mayor's Summer Night Lights program would begin. Michelle Austin indicated that it will start the first week of June along with the majority of the summer activities.

Councilperson Holleman asked how many police officers would be present at the Downtown Market. Jennifer Letourneau reported that they normally have 2 officers at the event. Councilperson Holleman mentioned that he had observations from last year regarding some safety concerns with the Franklin St. intersection.

Project Update

Annette Saul reported that the Sherwood Forest Park playground has a shipping date of May 24th and they hope to install in June. The Coy Lacy playground has been ordered. It is tentatively scheduled to be shipped in July and installed in August. Annette Saul also informed the committee that the synthetic turf for Edith Pettus Park has been delayed but should be delivered in early June.

Jennifer Letourneau discussed the project with the Army Corp of Engineers to dredge the old marina.
