MINUTES

CALL TO ORDER

The meeting of the Fair Housing Board was called to order by Chairperson Mark Kelly on Monday, May 23, 2022, at 10:00 a.m. in the Clarksville Neighborhood and Community Services Conference Room, 1 Public Square, Suite 201, Clarksville, Tennessee.
