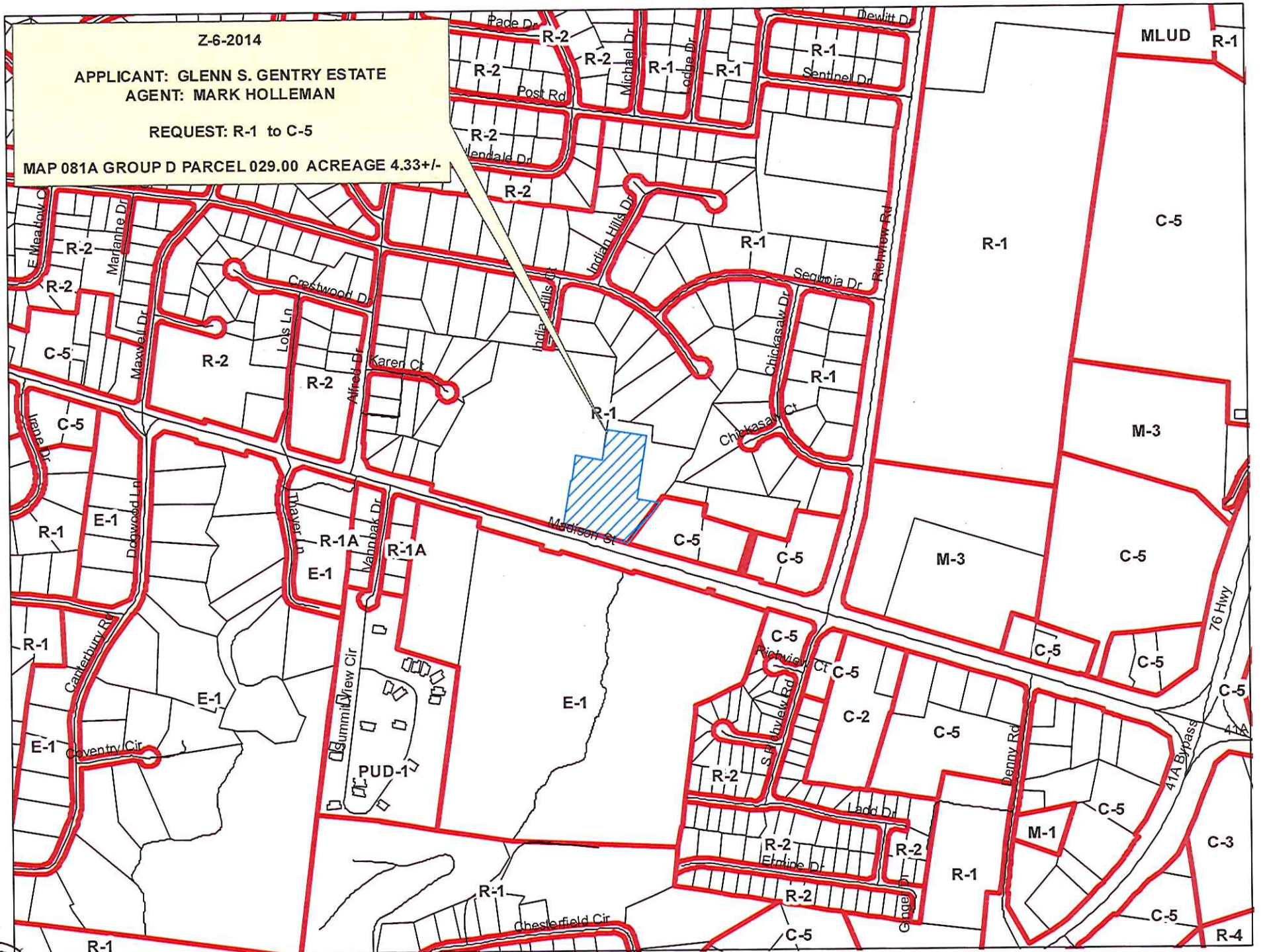
1. The proposed zoning request is inconsistent with Growth Plan (as in the City) and adopted Land Use Plan.

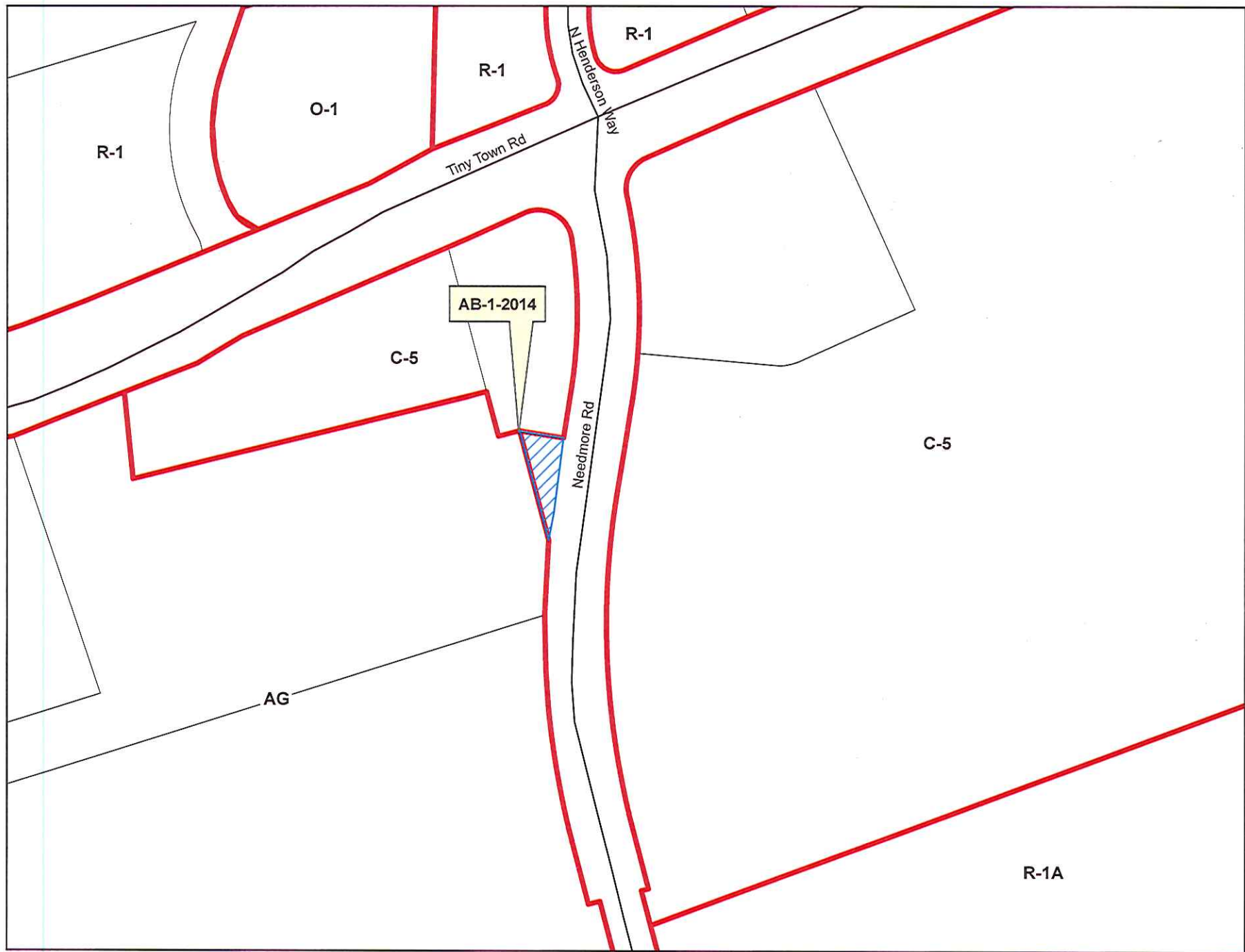
